CERTIFICATE OF INCORPORATION

FIRST STATE ROBOTICS, Inc.

A NON-STOCK AND NON-PROFIT CORPORATION

First: The name of the Corporation is First State Robotics, Inc.

Second: The Registered Office in the State of Delaware is to be located at:

33 Longspur Drive, Wilmington, 19808, County of New Castle.

The registered agent in charge thereof is John Anthony Larock, Jr.

Third: The purposes for which the First State Robotics, Inc. is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Fourth: Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States

Fifth: Upon the dissolution of the Corporation, its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law or shall be distributed to the federal government, or to state or local governments for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the County in which the principal office of the corporation is then located exclusively for the purposes or to such an organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
